# Report FIN-24-2025 2026 Rate Supported Operating Budget and Capital Forecast



For Consideration by Special Council on December 4, 2025

### **Objective:**

To provide Council with a high level summary of the 2026 Rate Supported Operating Budget and Capital Forecast.

#### **Recommendations:**

#### **Executive Summary:**

Haldimand County is responsible for the purification and distribution of potable water to its users and the collection and treatment of the resulting wastewater. This system is fully funded by the users, with no financial support from property taxes. Capital infrastructure is funded from user rates with offsetting funding from Development Charges and financial assistance from other levels of Government when available. The 2026 Rate Supported Water and Wastewater Operating Budget and Capital Forecast (Rate Budget) being presented for Council's consideration on December 4, 2025 contains the operational and capital water and wastewater requirements for 2026, as well as the forecasted capital needs for 2027-2035.

As Haldimand County's budget process now falls under the Strong Mayor's Powers, a review of the proposed timelines for 2026 was completed. Mayoral direction was provided to staff to present the budget with the intention that they would follow standard Haldimand County budget processes as closely as possible. There are elements within Strong Mayor Powers that allow this process to be further streamlined and follow Haldimand County's regular budgeting process more closely. This involves shortening some of the review periods allowed for under the Act, in order for the budget to be reviewed and approved by Council on the date it is to be presented. Through report FIN-19-2025, two recommendations were approved to shorten the review and override periods in order for the 2026 Rate Budget to be reviewed and approved on December 4, 2025.

A new rate study was conducted in 2025 and presented to Council on October 28<sup>th</sup>, 2025 through report FIN-21-2025 - Water and Wastewater Rate Model and Financial Plan Update. Included in the Rate Budget are the end user rates required to fund the applicable systems, as driven by the principles approved through the new study, many of which remain unchanged from the previous study conducted in 2013. The rates included in the draft budget vary slightly from what was projected through the rate study and presented to Council in October. The model forecasted an average monthly rate increase of 3.69% over the 10 year forecast, while the 2026 draft budget includes an average residential impact of 4.07% (\$3.67) per month. The differences between these two figures will be discussed in more detail in the Finance section of this report.

Though the "behind the scenes" calculations that determine the end user rates can be quite complex, the drivers of water and wastewater rates can be grouped into just a few categories. By looking at the drivers in this way, it can assist in better understanding how the rates are determined. There are three main factors that impact the rates annually:

- increase/decreases in gross costs;
- (ii) increases/decreases in miscellaneous revenues (i.e. bulk services, industrial recoveries, etc.); and
- (iii) changes in annual consumptions/number of customers. How these drivers impact the 2026 Rate Budget are highlighted in this report, with further details provided in the budget book.

If approved, the water and wastewater rates included in the current Special Council agenda package would be effective January 1, 2026.

## **Background:**

This report and supporting budget book will provide Council with information required to deliberate the 2026 Rate Supported Operating Budget and Capital Forecast and associated revisions to user rates and miscellaneous fees and charges. Haldimand County staff undertake a comprehensive budget review process to ensure operational requirements are being met in a fiscally responsible manner.

#### **External Influences on the Systems**

The Rate Budget is highly legislated, these legislated requirements include:

#### Safe Drinking Water Act, 2002

This act recognizes that the people of Ontario are entitled to expect their drinking water to be safe, provides for the protection of human health and the prevention of drinking-water health hazards through the control and regulation of drinking-water systems and drinking-water testing.

#### Statutory Standard of Care [Safe Drinking Water Act, 2002, Section 19]

Extends legal responsibility to Council requiring them to exercise the level of care, diligence and skill that a reasonably prudent person would be expected to exercise in a similar situation while acting honestly, competently and with integrity.

#### **Drinking Water Quality Management Standard (DWQMS)**

Ontario municipalities are required to comply with the Provinces Drinking Water Quality Management Standard (DWQMS) that was established in the wake of the Walkerton tragedy. The standard includes 21 elements that municipalities must comply with and covers a variety of operational, risk management, documentation, evaluation and process related tasks. The Standard of Care confers to municipal councils a responsibility to ensure that they have a functioning and effective DWQMS. Staff continually work to strengthen this system and ensure the County remains in compliance with this requirement.

#### Financial Plans [Safe Drinking Water Act, 2002, Section 30.]

Requires financial plans respecting the cost of water and waste water services be prepared in line with requirements set out in the Sustainable Water and Sewage Systems Act, 2002.

# Asset Management Planning for Municipal Infrastructure, O.Reg 588/17 [Infrastructure for Jobs and Prosperity Act, 2015]

This regulation prescribes information to be used when planning for municipal infrastructure. Water and Wastewater assets are considered "Core" in the Asset Management Plan.

## **Updated Rate Study**

Haldimand County has completed a comprehensive update to its Water and Wastewater Rate Study and Water Financial Plan, prepared by Watson & Associates Economists Ltd, which was presented to Council on October 28, 2025 through report FIN-21-2025. These documents provide a strategic framework to guide Haldimand's water and wastewater service delivery and cost recovery, ensuring long-term financial sustainability, regulatory compliance, and equity between all users. The updated rate model and financial plan reflect current infrastructure needs and forecasted growth, while maintaining Haldimand's commitment to full cost recovery and minimizing cross- subsidization between user groups. The Rate Study builds upon foundational principles established in the 2013 review, reaffirming methodologies such as the 50/50 fixed-variable revenue model, meter equivalency ratios, and functional cost allocation methodologies.

## **Strong Mayor Powers and the Budget Process**

As of May 1, 2025, the Government of Ontario expanded strong mayor powers to Haldimand County. As part of the strong mayor powers, Mayor Bentley has a duty to prepare and propose the budget before February 1, 2026.

The Rate Budget must be presented prior to December 31<sup>st</sup>, 2025 in order for the related rate changes to be implemented and in effect as of January 1<sup>st</sup>, 2026. Therefore, this budget will need to follow the protocols under Strong Mayor Powers, as it falls before the budget presentation deadline of February 1<sup>st</sup> stipulated in the legislation. Typically under this process, once the Mayor proposes the budget, Council has 30 days to meet and pass resolutions to amend the budget. If there are no amendments within the 30 day time period, the budget is deemed to have been adopted. Following the amendment period, the Mayor has 10 calendar days to veto budget amendments.

Strong Mayor Powers does allow for amendments to this time frame, which would allow the rate budget to be presented and passed prior to December 31, 2025, and allow for standard County budget processes to be followed. In order to accommodate this, a resolution was passed through FIN-19-2025 to:

- Shorten the budget review period from 30 to 0 days; and
- Shorten the veto period from 10 to 0 days.

By doing so, Council can review and approved the rate budget as presented on December 4<sup>th</sup>.

### **Analysis:**

There are limited financing sources available to the County to fund the necessary infrastructure replacements. As the water and wastewater systems are 100% self-funded from the users, there are limited customers to spread the burden of expensive project expenditures across (approximately 11,645 water users and 11,527 wastewater users in total anticipated in 2026). As the individual systems are funded specifically from the users of the relative systems (i.e. water users pay 100% of infrastructure costs related to the water system and wastewater users pay 100% of infrastructure costs related to wastewater systems), the funding sources are different for the two systems. The sources of financing for specific projects depend on the availability of funds and the nature of the capital projects. A long range plan was developed independently for water and wastewater infrastructure needs based on the 10 year forecasted costs. These principles are a major step towards sustainability and lifecycle costing of infrastructure needs.

## **Major Rate Impacts**

Though the "behind the scenes" calculations that determine the end user rates can be quite complex, the drivers of water and wastewater rates can be grouped into just a few categories. By looking at the drivers in this way, it can assist in better understanding how the rates are calculated, and what is causing changes year over year.

### **Customer Base and Consumption Trends**

- As 50% of the system costs are recovered by base/fixed charges, the more users there are
  on the system, the more these costs can be spread across, thus reducing the impact on the
  end user.
- The other 50% is recovered by consumption charges, meaning, the more water used overall, the lower the overall costs to the end users. However, should consumption trend downwards (ex. through conservation efforts or the loss of an industrial customer), the opposite would occur, and the end user could expect their consumption rates to rise.

**2026 Impact:** A thorough analysis of water and wastewater customers and their consumption was completed as part of the 2025 rate study. As a result, further refinement to the customer base has been incorporated in to the 2026 budget. Furthermore, a review of consumption trends shows the average residential consumption decreasing.

#### **Net Operating Expenses**

Net operating expenses are the total operating expenses, less any miscellaneous, non-metered revenue (i.e. bulk water, septic/holding charges, etc.). With budget impacts being spread over a limited number of customers, even small increases can have an impact on the end user. A 1% impact on the end user is approximately \$171,250 (\$89,820 water; \$81,430 wastewater).

- Increases in operating expenses will lead to higher rates, as these costs need to be spread over the same users.
- Increased miscellaneous revenues would have the opposite effect, and would assist in relieving pressures on the system users.

**2026 Impact:** A summary of the 2026 net operating expenditures has been provided below:

#### **Operational Expenditure Drivers**

The Rate Budget includes additional water operating expenditures of approximately \$620,000, mainly driven by:

- Hamilton water contract increases of \$286,000;
- Hydro increases of \$63,000;
- Base salaries increases of \$61,000; and
- Operations contract increases of \$55,000.

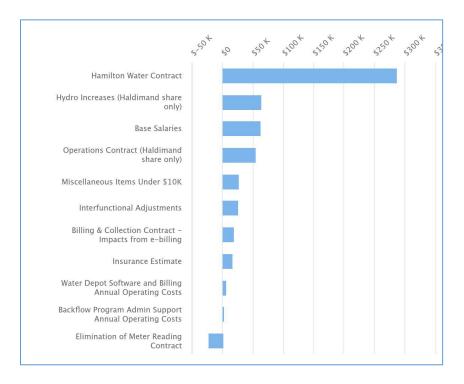


Figure 1: Water Operational Drivers

A summary of the operational water drivers can be found in Figure 1 below.

The Rate Budget includes additional wastewater operating expenditures of approximately \$442,000, mainly driving by:

- Operations contract increases of \$289,000 including a substantial increase in sludge hauling and repair and maintenance costs; and
- Hydro increases of \$44,000.

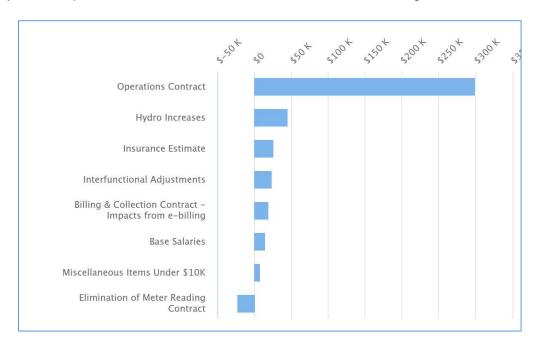


Figure 2: Wastewater Operational Drivers

A summary of the operational wastewater drivers can be found in Figure 2 below.

### **Miscellaneous Operational Revenues:**

Miscellaneous non-metered user fees have been indexed at 3% for 2026. An exception to these are the changes to special charges, including bulk water charges and fire protection. These fees were reviewed in further detail in the rate study, and as a result, there are changes to these fees in 2026.

The study addressed cost reallocation for services such as fire protection, leachate treatment, bulk water, and septic/holding haulage, ensuring that users pay in proportion to their system impact. The bulk water rate is proposed to decrease by 22.5%, from \$3.53/m3 to \$2.74/m3, resulting in a projected revenue reduction of approximately \$365,500. Conversely, the holding/septic rate is set to increase by 11.64%, from \$16.88/m3 to \$18.95/m3, which reflects the reintroduction of capital costs for a future Dunnville receiving station replacement, and is now incorporated into the single, blended rate structure and will support lifecycle replacement costs to ensure long-term sustainability of this service.

These fees form part of the user fee schedules, included in the current Special Council agenda package. If approved, these rates will be effective January 1, 2026.

## **Capital Financing**

Capital financing consists of the debt, reserves, and offsetting funding (i.e. development charges and grants) required to finance the capital plan. Historically, the Rate Supported budget has included a standard 1% additional allocation in capital financing to help fund the water and wastewater capital plan. This additional 1% has been allocated to the water reserve for the past number of years.

The process for funding the capital program was reviewed as part of the 2025 rate study, and as a result, amendments were made to how this financing is included in the budget. The rates included in the new study are the rates required to fund all operating and capital expenditures, offset by non-metered revenues. The rate model also incorporates established reserve principles, with the end result being a shift away from the 1% impact related to capital financing from prior years, replaced with a more accurate contribution required to meet the needs of the 10 year forecast.

Changes to the capital plan could also result in shifts to the end user rates, as the amount of financing required to fulfill the capital plan would come directly from contributions from the system users. Unidentified capital needs, or increases to costs for existing projects in the capital forecast could also require further capital financing to be allocated to the capital program in order for the related reserves to have sufficient funding to meet the demands on the water and wastewater infrastructure assets.

**2026 Impact:** As a result of the new rate study, and the requirements of the 2026-2035 capital forecast, the water capital reserve is seeing a reduction of approximately \$328,000 in 2026, while the wastewater capital reserve is seeing a reduction of approximately \$484,000. In addition to this, the rate study also recommended a one-time infusion to the water capital reserve of \$1.4 million from the water rate stabilization reserve. This recommendation has been included in the draft budget. The 2026-2035 capital forecast contains expenditures of \$179 million, with \$72 million related to the water systems, and \$107 million related to the wastewater systems. These projects are funded from a variety of sources, including capital reserves, development charges, development charges related debt, and grants.

# Financial/Legal Implications:

The Draft Rate Supported Operating Budget incorporates both the requirements to meet the operational needs for both the water and wastewater system, as well as the majority of the financing needs to meet the current planned capital forecast. Any significant changes to rate impact categories discussed above (customer base and consumption, net operating expenses, and capital financing) will ultimately impact the rates required from the end users.

The rate study presented to Council on October 28<sup>th</sup> noted an average impact on users of 3.69% over a 10 year period. This 10 year impact is the lens in which the rate study was fundamentally developed and approved, rather than the individual increases between two years. Though the 2026 draft impact is 4.07%, the new draft budget figures and forecasted amounts result in a 10 year average impact of 3.85%. Staff continue to utilize the approved 6% "average" increase year-over-year on the water side and 2% "average" increase year-over-year on the wastewater side presented in the study, so any end user impacts are solely due to differences in customers and volumes between the rate study and the budget. There are three main factors driving these differences:

- Lower than anticipated residential growth in 2025;
- Better customer information, specifically lower commercial wastewater customers; and
- A correction in one large industrial customer's wastewater usage.

Due to the full cost-recovery methodology, any shift in one customer group's numbers has an offsetting impact on the other groups, including residential, for the same amount of total revenue to be collected.

While both the water and wastewater capital reserves meet Haldimand County's financial principles up until 2033, after this point the water capital reserve deficit exceeds the 25% of annual contributions threshold throughout the remainder of the forecast. The rate study recommendations of 6% and 2% align with reserve principles, but the draft capital budget came in higher than the 2025 approved

budget and forecast, causing a strain on the reserve balance, resulting in non-compliance with the reserve principles.

As the capital budget continues to better align with Haldimand County's asset management requirements it can be anticipated that this information will continue to change over time. Having an accurate capital forecast is a critical component to ensuring the reliability and accuracy of the rate structure under the principles of the new rate study.

#### **Stakeholder Impacts:**

Haldimand County has a responsibility to present a fiscally sustainable budget based on sound financial principals. Given the limited user group of the water and wastewater systems, presenting a fair and equitable water and wastewater budget that meets both the operational and long term financial needs of the users of the systems is critical. The updated rate model, as reflected in the 2026 Draft Rate Supported Water and Wastewater Operating Budget and Capital Forecast reflect current infrastructure needs and forecasted growth, while maintaining Haldimand's commitment to full cost recovery and minimizing cross- subsidization between user groups.

#### THE CORPORATION OF HALDIMAND COUNTY

By-law Number /25

# Being a by-law to establish water and wastewater fees and service charges and to repeal By-law 2568/24

**WHEREAS** Section 391 of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, (the Act) provides that a municipality may pass by-laws imposing fees or charges for services or activities provided, for costs payable for services or activities provided or done by or on behalf of the municipality and for use of its property including property under its control;

**WHEREAS** The Corporation of Haldimand County deems it necessary to impose water and wastewater fees and charges;

**WHEREAS** the Council of The Corporation of Haldimand County has, from time to time, established various fees and charges for water and wastewater supply, services, activities and use of Haldimand property,

**AND WHEREAS** the Council of The Corporation of Haldimand County deems it expedient to enact a by-law establishing and requiring the payment of water and wastewater fees for supply, services, activities and use of Haldimand property,

# NOW THEREFORE, the Council of The Corporation of Haldimand County enacts as follows:

- THAT the water and wastewater fees and charges as set out in Schedules "A" through "E", attached hereto and forming part of this by-law, are hereby established and adopted by The Corporation of Haldimand County.
- 2. THAT, unless otherwise prescribed, no request by any person for any water and wastewater supply, service, activity or use of Haldimand property described in Schedules "A" through "E" will be processed or provided by any Haldimand County Official, unless and until the person requesting the water and wastewater supply, service, activity or use of Haldimand property has paid the applicable water and wastewater fee or charge in the prescribed amount as set out in Schedules "A" through "E" to Haldimand County.

- 3. THAT in the event that any water and wastewater supply, service, activity or use of Haldimand property is requested by a person, and a fee or charge for such water and wastewater supply, service, activity or use of Haldimand property has not been specifically provided for in Schedules "A" and "D" hereto, a water and wastewater fee or charge shall be calculated by Haldimand County staff utilizing the formula described in Schedule "E", attached hereto and forming part of this by-law, and such water and wastewater fee or charge shall be deemed to be a water and wastewater fee or charge otherwise established and adopted by Council and shall be deemed to be included in Schedules "A" through "D".
- 4. THAT in the event that any information, service, activity or use of Haldimand property is obtained or incurred by a person, and a fee or charge for such information, service, activity or use of Haldimand property has not been specifically provided for in Schedules "A" through "D" hereto, a fee or charge shall be calculated by Haldimand County staff utilizing the formula described in Schedule "E", attached hereto and forming part of this by-law, and such fee or charge shall be deemed to be a fee or charge otherwise established and adopted by Council and shall be deemed to be included in Schedules "A" through "D".
- 5. THAT unless otherwise prescribed, the fees and charges established by this by-law shall be payable to The Corporation of Haldimand County by cash, money order, certified cheque, cheque, debit card, through a financial institution, or online via credit card when due.
- 6. THAT where any payment is received on account, the payment will first be applied against late payment charges owing according to the length of time the charges have been owing, with charges imposed earlier being discharged before charges imposed later. The payment will then be applied against the total amount owing according to the length of time they have been owing, with amounts imposed earlier being discharged before amounts imposed later.
- 7. **THAT** a percentage of one and one-quarter percent (11/4%) shall be imposed as a penalty for non-payment of fees and charges remaining unpaid on the first day following the last day for payment of such fees and charges and thereafter, an additional charge of one and one-quarter percent (11/4%) shall be imposed and shall be added to any remaining fees and charges remaining unpaid on the first day of such calendar month in which the default continues until a new by-law is established.

- 8. THAT the Treasurer is authorized to adjust penalty/interest applied above under the following conditions: (i) if Haldimand County has applied said penalty/interest in error, at the sole discretion of the County, 100% of the penalty/interest applied will be removed; or (ii) if Haldimand County, at its sole discretion, was negligent or contributed in part to the application of the penalty/interest in error, 50% of the penalty/interest will be removed. All further adjustments to penalty/interest require specific Council approval or an appeal to the applicable Provincial court.
- 9. **THAT** the Treasurer is authorized to write off small unpaid balances under\$10 as the Treasurer deems appropriate.
- 10. **THAT**, in the event any part of this by-law, including any part of Schedules "A" through "D", is determined by a Court of competent jurisdiction to be invalid or of no force and effect, it is the stated intention of Council that such invalid part of the by-law shall be severable and that the remainder of this by-law including the remainder of Schedules "A" through "D", as applicable, shall continue to operate and to be in force and effect.
- 11. **THAT** in the event another by-law of The Corporation of Haldimand County establishes a fee or charge for water and wastewater services that is not referenced by this by-law and that is not inconsistent with this by-law, the fee or charge established by that or other by-law shall be deemed to be included in Schedules "A" through "D" attached hereto.
- 12. **THAT** the fees and charges set out in this by-law shall be effective for any bills issued on or after January 1, 2026 for services rendered on or after January 1, 2026.
- 13. **THAT** any provision of any by-law that is inconsistent with this by-law shall be hereby repealed.
- 14. **THAT** this by-law shall be known as the "Water and Wastewater Fees and Service Charges By-law".
- 15. **THAT** By-law 2568/24 and any amendments thereto are hereby repealed in their entirety.

16. **AND THAT** this by-law shall be effective January 1, 2026.

If the meter is found to be accurate, the customer must pay carrying charges and cost of testing, in addition to payment in full of the bill(s) in question. The following is an excerpt from Haldimand County's Water Use By-Law describing how the charge for testing of meters works.					
Testing Requests	"No person shall test any meter except the Water Purveyor. The Water Purveyor shall remove and test any meter by an owner or agent of the owner. If the meter is found to be inaccurate, Haldimand shall adjust the water bill accordingly. A new or rebuilt displacement meter from 17mm (5/8) to 50mm (2") in size will be deemed to be inaccurate if it records outside of the accuracy limits of 98.5 to 101.5 percent on high and intermediate flows and 95.0 to 101.0 percent on low flows. New and rebuilt compound meters, turbine meters, multi-jet meters and propeller meters from 50mm (2") to 250mm (10") in size will be deemed to be inaccurate if they record 2 percent higher or lower than the manufacturers' recommended accuracy limits. Repaired meters of all sizes will be deemed to be inaccurate if they record outside of the accuracy limit of 90 percent minimum. A rebuilt meter is defined as one that has had the measuring element replaced with a factory-made new unit. A repaired meter is defined as one that has had the old measuring element cleaned and refurbished."

A customer may request their water be turned on or off due to an internal plumbing problem or for seasonal protection of the plumbing. Haldimand County Finance may initiate a turn off due to non-payment of a bill. The following is an excerpt of Haldimand County's Water Use By-Law.

"No person shall turn off or turn on a water service except the Water Purveyor. If the Water Purveyor is requested to turn off or turn on a water service, a service charge as detailed in Miscellaneous Charges is to be paid, it being understood that no water service will be turned off or turned on unless the consumer or another person authorized in writing to act on his behalf, is present on the premises."

# Being a by-law to confirm the proceedings of Council of The Corporation of Haldimand County

**WHEREAS** Section 5 of the *Municipal Act*, 2001, S.O. 2001, c. 25, as amended, (the Act) provides that the powers of a municipality shall be exercised by its Council and that a municipal power shall be exercised by by-law;

**WHEREAS** Section 10(1) of the Act stipulates that a single-tier municipality may provide any service or thing that the municipality considers necessary or desirable for the public;

**AND WHEREAS** in many cases action which is taken or authorized to be taken by Council does not lend itself to the passage of an individual by-law,

# NOW THEREFORE, the Council of The Corporation of Haldimand County enacts as follows:

- THAT each motion, resolution and other action of the Council of The Corporation of Haldimand County passed and taken by Council at its Special Council meeting held on the 4th day of December, 2025 be and are hereby approved, adopted, ratified and confirmed.
- 2. THAT where no individual by-law has been or is passed with respect to the taking of any action authorized in or by the above-mentioned minutes or with respect to the exercise of any powers by the Council in the above-mentioned, then this by-law shall be deemed for all purposes to be the by-law required for approving and authorizing and taking of any action authorized therein or thereby, or required for the exercise of any powers therein by the Council.
- 3. AND THAT the Mayor and the proper staff of The Corporation of Haldimand County are hereby authorized and directed to do all things necessary to give effect to the said action of the Council or to obtain approvals where required and, except where otherwise provided, the Mayor and the Clerk are hereby directed to execute all documents necessary on behalf of The Corporation of Haldimand County and to affix the corporate seal thereto.
