The Chair called the meeting to order at 6:00 p.m.

#### **B. Land Acknowledgement**

Chair N. Hedley read the Land Acknowledgement statement.

#### **D. Approval of Previous Agricultural Advisory Committee Minutes**

1. Agricultural Advisory Committee Minutes - September 17, 2025

**E. Items for Consideration**

1. Alternative Land Use Services (ALUS) Haldimand

C. Blott provided an introduction to Haldimand Stewardship Council, noting it is a restoration, non-profit organization. C. Blott also introduced Alternative Land Use Services (ALUS), noting that it has been operating for over 20 years. The Haldimand Stewardship Council is looking to establish an ALUS presence in Haldimand. Norfolk ALUS has agreed to be the legal entity for Haldimand to begin (3 years to start) with the expectation that a permanent legal entity will be established for Haldimand. They are currently looking for Farmers that may be interested in joining a Partnership Advisory Committee.

Highlights included:

- Overview of the ALUS funding program looking at restoring low-production farm land;
- ALUS program partners well with all of the existing farmland restoration programs;
- Multiple successful species at risk projects in Haldimand;
- Haldimand Program Coordinator to assist with securing funding;
- The local legal entity organizes fundraising, in addition to the Canada wide company;
- Most of the funding is supplied by Federal, Provincial, Stewardship Councils, Private and Corporation donations; and
- Land owners receive compensation per acre.

Discussion ensued regarding uptake in Haldimand, success in Norfolk County, working with Conservation Authorities, and requirements of being a board member for the Haldimand Stewardship Council.

2. Rural Water Quality Program

L. Heyming provided an overview of the 2025 program financials, highlighting this year's partnership with Ducks Unlimited on wetland habitats.

S. Brocklebank presented File 142, a cover crop proposal consisting of a 30-acre field adjacent to a watercourse and wetland.

Discussion ensued regarding tilling and ground coverage.

S. Brocklebank also presented File 143, a special project with the purpose of clean water diversion.

Currently, the rain water is draining off the applicant's barn, through the manure pile and then draining into the water way. The proposal is to divert barn roof water away from outdoor yard and manure pile by installing 183' of eavestroughs to direct water away from pile and have water flow by tile underground to outlet on adjacent hay field. The farm has already completed an environmental farm plan.

The committee further discussed the farms operations, location of the manure pile, field erosion at the proposed output, location of water for animals, tiling, post-installation plan and environmental benefits.

### **3. Engineering Role with AAC**

J. Easson shared that Report ENG-12-2025 Traffic Management Strategy Final Report included the following recommendation:

Recommendation #4; Strengthen Haldimand County's role in the Agricultural Advisory Committee: Establish a permanent engineering role in the Committee to ensure timely acknowledgment of issues and mitigative measures.

To summarize, J. Easson shared that the Manager of Engineering thought it would be beneficial to receive the committee's input on how they would like engineering staff to be involved.

The committee discussed different types of information session formats, timing of meetings relating to budget input, working with the Traffic Management Strategy Committee on farm routes for heavy traffic areas and signage concerns at intersections.

#### **4. Workplan Discussion**

##### **Agricultural 101 Toolkit**

J. Easson provided an overview of the "Durham Ad 101" training package that provides awareness on general agricultural impacts and challenges, that this committee could reference if creating a similar toolkit for Haldimand County.

L. Romanuk added that Durham uses this guide with Council especially after elections to familiarize new Council members.

Discussion ensued surrounding the establishment of a Haldimand Agricultural Toolkit, with highlights such as farm policies, RWQP stats, leveraging general Haldimand Agricultural statistics, biosecurity, and where the toolkit will be located (i.e. website, physical, etc.).

L. Romanuk added that Economic Development and Tourism can create content on social media, including spotlights on different farmers, successes and topics that can also be highlighted on the website. Additionally, campaigns can be run with ideas from the committee.

The committee confirmed their support on this work and the above noted ideas.

##### **Workshop for the Agricultural Committee**

J. Easson discussed additional workplan items including holding a workshop for the Agriculture community.

A committee member suggested that may be beneficial if a Haldimand County representative attended all of the different commodity AGMs.

The committee noted that HFA is planning to organize a similar event or workshop series and suggested that a partnership could be established.

### **Annual AAC Council Presentation**

J. Easson shared the 2025 presentation format and asked the committee if there are any other stats and information that they would like shared in the 2026 presentation.

The committee discussed updates to the presentation including new workplan items, more specific stats, roadway concerns and tariff impacts on agriculture.

## **5. Council Update**

Councillor Adams provided an update from Council. The following items were highlighted:

- North Caledonia Employment Lands;
- Bill 21;
- New CAO, Michael Di Lullo;
- The Caledonia Emergency Services Grand Opening;
- Old Caledonia Fire Station declared surplus;
- Budget preparations are underway a short survey is available online for the public;
- New insurance rates for Haldimand County increased by 11%; and
- Councillor Adams advised that he has directed the ward specific vibrancy funding to the restoration of the pumper truck in Hagersville.

## **6. Economic Development & Tourism Update**

L. Romanuk provided highlights on the following EDT projects:

- Business Breakthrough Quiz and Local Meet-ups;
- Small Business Week Breakfast held on October 24<sup>th</sup> at the Jarvis Community Centre;
- Tourism FAM Tour on October 1<sup>st</sup>;
- Holiday Wish book;
- Renewable Energy Projects; and
- Three Haldimand County students were sponsored through the Brantford Resource Centre, Summer Company program.



## 7. Agricultural Organizations Update

Christian Farmers Federation of Ontario, R. Blyleven – Provincial meetings are going on until the end of March.

Haldimand Federation of Agriculture – C. Snyder shared that last month they had an AGM at Kohler, noting that Boralex was a guest speaker, providing information on their projects. Boralex offered a tour for HFA members.

Grain Farmers – K. VanderSpek noted that the next local meeting is scheduled at the beginning of December and that the AGM is at the beginning of January. The Grain Farmers Legacy scholarship program continues to reinvests into the education of the agri-food sector.

Ontario Soil and Crop Improvement Association - D. Court noted that the Niagara and Hamilton OSCIA will be hosting a summit with guest speakers at Ancaster fair grounds.

Chicken Farmers - H. Lise shared the Chicken Farmers went to Queen's Park to raise awareness for hatching and turkey security. Tariffs are taking 10% of economic value on boilers which has a large negative impact across Ontario.
